The options vest and become exercisable as to $25 \%$ of the shares of Common Stock of the Issuer subject to each such option on $3 / 15 / 16$ and as to $6.25 \%$ of such shares at the end of each successive threemonth period thereafter, subject to the reporting person's continued employment with the Issuer through each vesting date.
