Sabre Corporation Announces Sale of Common Stock by Existing Shareholders

SOUTH LAKE, Texas, Nov. 26, 2018 /PRNewswire/ -- Sabre Corporation ("Sabre" or the "Company") (NASDAQ: SABR) today announced the secondary public offering of approximately 23,386,376 shares of common stock, representing all of the shares of common stock held by existing stockholders affiliated with TPG Global, LLC and Silver Lake Management Company II, L.L.C. (the "Selling Stockholders"). The Selling Stockholders will receive all of the net proceeds from this offering. No shares are being sold by the Company.

Goldman Sachs & Co. LLC is acting as the sole underwriter for the offering.
