



Sabre Corporation Announces Pricing of Secondary Offering of Common Stock

SOUTHLAKE, Texas, Nov. 26, 2018 /PRNewswire/ -- Sabre Corporation ("Sabre" or the "Company") (NASDAQ: SABR) today announced the pricing of the previously announced secondary public offering of 23,304,636 shares of common stock by existing stockholders affiliated with TPG Global, LLC and Silver Lake Management Company II, L.L.C. (the "Selling Stockholders"), at a price to the public of \$24.95 per share. The Selling Stockholders will receive all of the net proceeds from this offering. No shares are being sold by the Company.

Goldman Sachs & Co. LLC is acting as the sole underwriter for the offering.
