Sabre Corporation Announces Closing of Secondary Offering of Common Stock

SOUTHLAKE, Texas, Nov. 29, 2018 /PRNewswire/ -- Sabre Corporation ("Sabre" or the "Company") (NASDAQ: SABR) today announced the closing of a secondary public offering of 23,304,636 shares of common stock by existing stockholders affiliated with TPG Global, LLC and Silver Lake Management Company II, L.L.C. (the "Selling Stockholders"), at a price to the public of \$24.95 per share. The Selling Stockholders received all of the net proceeds from the offering and no longer own any shares of common stock of Sabre. No shares were sold by the Company.

Goldman Sachs & Co. LLC acted as the sole underwriter for the offering.

A registration statement on Form S-3 (including a prospectus) relating to these securities has been filed with the Securities and Exchange Commission and is effective.
